HOURS OF OPERATION and COURT FEES:

The Mobile Tennis Center is open Monday - Thursday 8:00 AM – 9:00 PM, Friday 8:00 AM - 5:00 PM. Saturday 8:00 AM - 5:00 PM and Sunday 9:00 AM - 5:00 PM. Mobile Tennis Center features 60 lighted Laykold courts, is open 7 days a week throughout the year, and is closed on all major holidays.

 Senior Discount - \$1.00 off of court fee. Students w/ ID - \$2.00 before 5:00 PM

Cottage Hill Tennis Center is open Monday - Thursday 8:00 AM - 11:00 AM, 5:00 PM – 9:00 PM, Friday 8:00 AM – 11:00 AM and Saturday 8:00 AM – 12:00 PM. The center features 10 lighted Laykold courts, is open 6 days a week throughout the year, and is closed on all major holidays. Gates remain open to public after hours of operation.

Lyons Park Tennis Center is open Monday - Thursday 3:00 PM - 9:00 PM and Saturday 8:00 AM – 1:00PM. The center is closed Fridays. The center features 5 lighted Laykold courts, is open 5 days a week throughout the year, and is closed on all major holidays.

All U.S.T.A. and B.A.T.A. League matches are considered as prime time and will pay the evening rate regardless of the time of day.

COURT RESERVATIONS:

Reservations may be made for any time of day prior to 8:00 PM. Reservations will not be held more than 30 minutes past the original reservation time. Reservations are taken on first come, first serve basis.

RULES AND REGULATIONS:

1. SMOKING AND THE CONSUMPTION OF ALCOHOL IS PROHIBITED.
2. Regulation tennis shoes and shirts must be worn at all times.
3. If others are waiting, play time is limited to 2 hours.
4. Tournaments and League play take precedence.
5. Both (Members and non-members) must check in at the City Desk before entering courts.
6. Court fees MUST be paid before courts are assigned.
7. Profanity, loud noises, racket throwing, abuse or misuse of City property, etc. will not be tolerated. Failure to comply will result in suspension from the facility.
8. Games and excessive horseplay are not allowed on the premises.
9. Teaching others for pay is prohibited.
10. Rollerblading, roller-skating and skateboards are Prohibited at all times.
11. ***Service dogs are the only animals or pets allowed.***
